- A) THE DAILY RATES ARE FROM DROP OFF UNTIL NEXT DAY AT 5:00 PM. DROP OFF AND PICK UP TIMES ARE FROM 9:00-5:00 PM MONDAY TO SATURDAY (SUNDAYS AND HOLIDAYS BY APPOINTMENT ONLY)
- B) IF A DOG BECOMES ILL AND THE OWNER CANNOT BE NOTIFIED, YOUR OWN VETERINARIAN WILL BE CONTACTED. IF THIS IS NOT POSSIBLE, WE RESERVE THE RIGHT TO USE A VETERINARIAN WE CHOOSE. ALL EXPENSES WILL BE PAID BY THE OWNER OF THE DOG.
- C) ALL PETS ARE BOARDED BY THE POSH POOCH ARE WITHOUT LIABILITY ON OUR PART FOR LOSS OR DAMAGE FROM DISEASE, DEATH, RUNNING AWAY, THEFT, FIRE, INJURY TO PERSON, OTHER DOGS OR OTHER UNAVOIDABLE CAUSES.
- D) IF ANY PET THAT IS BOARDED AT THE POSH POOCH IS NOT CALLED FOR WITHIN 5 DAYS OF PICKUP DATE, THE DOG WILL BE DISPOSED OF AT THE DISCRETION OF THE POSH POOCH
- E) THE OWNER REPRESENTS THAT HE/SHE IS THE LEGAL OWNER OF THE DOG AND THAT THE ANIMAL HAS BEEN FULLY VACCINATED BY SHOWING THE VACCINATION RECORDS
- F) ANY PERSON REMOVING A DOG FROM THE POSH POOCH PREMISES WITHOUT THE PERMISSION OF THE POSH POOCH STAFF, REGARDLESS WHETHER OR NOT THE PERSON IS THE OWNER OF THE DOG, RISK THE POSSIBILITY OF TRESPASSING AND/OR THEFT CHARGES.
